



Pumas San Bernardino Parent Financial Commitment and Expectation

In order to ensure that the club operates in a professional manner parent's are expected to maintain their financial account in good standings by paying the yearly registration fee and monthly dues on a timely basis.

The registration fee of membership to Pumas San Bernardino for the 2008/2009 season is **\$250**. Each member will be required to pay the club dues (\$250) to cover the cost of Cal South player registration, CSL team registration, Field\Light and Complex maintenance, Club Insurance, Website maintenance, Field maintenance, Field equipment and Training Equipment and other club professional services as needed. Registration fees are due by May 1st for the 2008-2009 season (May 2008 –April 2009). The registration fee amount will also help to pay for a control system to be in place with Professional Accounting Firm to insure proper billing for members and taxes to be paid by the club.

Uniform Fees. Please read and sign the Pumas – Parent Uniform Purchase agreement form

A member that has fully paid the club dues and uniform fees would be considered in good standing. Each member's parent(s) are expected to donate time during our Club sponsored tournaments. We ask that parents donate 5 hours per year during our events.

Monthly Training Fees. A fee of \$60 is due by the first day of each month. An additional \$5 fee will be added to those dues not paid by the 10th of each month. An additional \$15 fee will be added to those fees not paid by the 25th of each month. Our fees are some of the lowest for club teams in Southern California and in order for us to main them at an affordable price we need our members to pay on a timely manner. It is not our wish to charge late fees but late fees will NOT be waived if monthly fees are not paid on time.

Other Fees: There are other costs related to playing in a San Bernardino Pumas team, they are (but not limited to); Tournament entry fees, personal training gear, sweats, balls, and personal bag. This team related fees are separate and will be billed individually. We have made arrangements with a local vendor to have these items available at a discounted price to our members. Tournament entry fees will be divided by 15 players. (example: \$600 fee divided by 15 = \$40 per player).

Parents understand that a player can be prevented from being registered with the our club and player will not be allowed to participate in practices, games or tournament play with any Pumas team until all fees are paid and kept current. The parent agrees to let the Club Manager and Director of Coaching know if they will be having any difficulty paying membership fees on schedule. Parent understands that the subsequently listed payments are non-refundable and due on dates set forth below. Any requests for partial or complete scholarship considerations by Pumas San Bernardino must be submitted in writing to the Club Manager prior to the first payment due.

MAKE ALL CHECKS PAYABLE TO: " Blast SC". Payments must be made at the Snack Bar, you will be issued a receipt. Payments will also be accepted on our web site. We will NOT accept cash as payment, please make other arrangements.
